Short-term visiting professors

Presentation and Objectives

Each year, the EHESP allocates budgetary resources to welcome colleagues from foreign academic institutions.

The short-stay mobility scheme for visiting professors offers a **minimum duration of 2 weeks to 4 weeks per visiting professor**.

The aim is to encourage the reception of foreign teachers and researchers in order to strengthen international exchanges in the fields of research and training at the EHESP.

Visiting professors must present **at least one conference of general interest or one course per week**, dedicated to the training of students and/or doctoral students, in collaboration with the EHESP and taking into account the specificities of its components.

This call for applications is addressed to any person, French or foreign, **practicing and residing abroad**, whose skills and project are considered relevant for the EHESP in the field of research and training.

In order to ensure transparent and fair management of the selection process, a Commission will be set up and will meet after the end of the call for applications to carefully consider each application received. Its objective will be to ensure that the selected visiting professors correspond to the research and training needs and priorities of the EHESP.

Discharge

The visiting professor receives a **lump sum of €1000 per week to cover accommodation and catering costs**. In addition, in order to facilitate travel, **another travel assistance of €500 may be requested** for persons coming from countries listed attached.

A first payment of the allowance will be made after the signature of the certificate of arrival and the rest will be received at departure. The time limit for international transfers is three to four weeks.

It is important to note that the allowance may under no circumstances cover an extension of the stay for personal reasons.

Applications

To apply for the EHESP Short-term visiting professors :

1. Application file:

- **Application form completed and signed**, validated by the relevant components (with the opinion of the Pedagogical Component and the host department).

- **CV accompanied by a list of publications**, written in French or English.

2. Submission of the Application File:
